

# **GUIDELINES TO PARTICIPATE**

Carefully read the guidelines to participate in the **nineth edition** of **Postcards from Civitavecchia**.

## HOW TO PARTICIPATE

Participation is **free and open to all**: amateurs and professionals, without regard to age or national origin.

If you want to participate, you must:

- Send an e-mail to <u>redazioneweb@portmobility.it</u>, attaching one or more photos. Don't forget to put a **title** and to write your **name**, **surname**, **telephone number** and **city of origin**. For large files, we recommend you use the free cloud WeTransfer (<u>www.wetransfer.com</u>).
- The photos do not have to be necessarily unpublished, but you can't attach a photo you already used for a previous edition of Postcards from Civitavecchia.
- Photos participating to the Calendar 2024 must be sent without signature.
  Pictures selected for the calendar will be accompanied by author's data (Name, Surname and Title), following the same graphic style.
- Photos with advertising logos will not be accepted.

# POSTCARDS FROM CIVITAVECCHIA 2024: THEME

The theme of the 9th edition is "A matter of perspective".

""Just when you think you think you know something you have to look at it in another way. Even if it may seem silly, or wrong, you must try."."

The perspective from which we observe the world around us has an influence on our thoughts, our decisions and, in general, on our lives. Sometimes, we only need to change our point of view a little to notice something we had not noticed before. A detail that we had overlooked or, on the other hand, a global "vision" that we had not yet grasped.

There's **beauty** that often goes unnoticed. Our eyes always look from the same angles. In photography, perspective refers to the spatial relationship between the subjects in the frame. **The way an image is composed helps to see something new**.

It's quite common that the view of something from a different point of view leads to opposite interpretations and different meaning. It is really the case to say that it's all a matter of perspective.

## **TERMS AND CONDITIONS OF PARTICIPATION**

- All participants can send their photos from 14th October to 20th November 2023 (not later than 23:59 GMT+1).
- Both horizontal and vertical orientation is accepted. The photo format must be JPG, PNG or TIFF (For the calendar, only horizontal orientation will be accepted).

# MORE DETAILS ABOUT THE CALENDAR 2024

12 photos will be selected for the new calendar 2024 "Postcards from Civitavecchia".

Participants need to bear in mind that, for technical reasons related to printing, the photos for the calendar must have the following characteristics:

- A minimum resolution of **300 dpi**.
- Horizontal orientation (3:2, landscape orientation) and a size of 30 x 20 cm (as minimum).

If the photos don't meet these requirements, they will be automatically excluded from the calendar contest. But all the photos will be published on Port Mobility website and on our social networks.

- Port Mobility staff members abstain to participate in the contest.
- All participating photos will be evaluated by a qualified expert jury.

#### PRIVACY

#### 1. Treatment of personal data

Under the art. 13 of EU General Data Protection Regulation 679/2016/CE, S.p.A., we would like to inform you that the personal data you provide for the contest "Postcards from Civitavecchia 2021" (from now on, the "Contest"), including the data provided through the website www.portmobility.it, will be processed by Port Mobility SPA (from now on, the "Company") as data holder, in manual, printed, electronic or telematic mode. In its own quality of data holder, the company proceeds to save personal data conferred in a server located in Europe. The database is accessible only by authorized persons, ensuring the security and confidentiality, thanks to the adoption of safety measures designed to prevent the loss of data, illicit or incorrect use and unauthorized access. The period of storage of the data is determined based on the objectives underlying the treatment operations implemented and had regard to the type of the data given. In any case the duration of the retention of data will exceed the time strictly necessary to fulfill the purposes for which it was provided by the present disclosure.

#### 2.Finality of treatment

The personal data are collected and processed by the company exclusively for managing its registration in the site and the participation to the contest as well as for administrative purposes. The data you conferred may also legitimately be used by Port Mobility to comply with legal obligations to which the company is subject, or even in the cases in which the treatment is necessary for the protection of the rights of the company and/or its dependants. The aforesaid purpose of treatment does not require your consent. Thus, the activities of treatment which are entrained will be implemented following the simple conferral of data from your part.

#### 3. Provision of data

The provision of data is optional: however, without the provision it'impossible to participate in the contest and to be notified in case of winning.

#### 4. Notification and dissemination of data

The personal data may be communicated to third parties responsible for the execution of the processing operations within the framework of the objectives referred to in point 2, and to this end appointed external responsible of the treatment. Among them we indicate Euromedia S.r.l., for the fulfilment of contractual obligations of Port Mobility Spa in your regard within the scope of the registration to the site and of the management of the contest. The communication of the data will be limited to European territory in respect of current legislation. Your data will not be subject to dissemination.

#### 5. Data holder

The data holder is Port Mobility Spa.

#### 6. Responsible for data protection

#### 7. Rights of the user

As concerns the treatment of your personal data, you may exercise the rights referred to in Articles 15 and following of the EU Regulation 679/2016 by request addressed without formality to the data holder of the treatment, writing us an email to <u>Dpo@innovationlab.srl</u>. This request will be provided a suitable answer without delay. In particular, you have the right:

• to access to personal data that concern you and to obtain all the information concerning the treatment of the same data listed by the Regulation.

• to obtain the amendment, and integration, respectively, of incorrect or incomplete data.

- to obtain the cancellation of his data in the situations provided for by Article 17 of the Regulation.
- to obtain the limitation of treatment in cases provided for by Article 18 of the Regulation.

• to receive from the holder of the personal data in structured format, of common use and readable by automatic device and to transmit them to another holder of the treatment (Portability).

• to submit a complaint to the supervisory authority about the treatment of data that concern him, within the meaning of Article 77 of the Regulation.

#### 8. Underage users

Site registration and participation in the competition are allowed only to users older than sixteen years old. In case of users younger than 16, you need the written consent of both parents and guardian.
