GUIDELINES TO PARTICIPATE

Read carefully the guidelines to participate in the **5th edition** of Postcards from Civitavecchia.

HOW TO PARTICIPATE

Participation is **free and open to all**, professional photographers or just passionates, with no restrictions of age or origin.

In order to participate you need to:

- Send an **e-mail** to the address redazioneweb@portmobility.it attaching the picture and writing your surname, family name, phone number and city of origin. For files of big dimensions it is advisable to send an email through the cloud transfer service offered by **WeTransfer** (www.wetransfer.com).
- Alternatively, you can hand in the material personally (in cd-rom, dvd, pen drive) to our offices at Prato del Turco snc, Civitavecchia, in the following hours: Monday-Thursday from 8am to 5 pm and Friday from 8am to 4 pm.
- Pictures may have been published before, but they must not have participated to the previous editions of Postcards from Civitavecchia.
- Pictures participating to the Calendar 2020 must be sent **without signature or marks**. Pictures selected for the calendar will be accompanied by the author details (Name, Surname and Title) following a common graphic style.
- Pictures with logos or brands with publicity purposes will not be accepted.

POSTCARDS FROM CIVITAVECCHIA 2020: THEME

The chosen theme for the 5th edition is “**Hidden Civitavecchia**”.

So, we invite all contestants to show through one or more pictures the **places, stories and tales of an unknown Civitavecchia**, maybe the suburbs or dusty places, but just because these spots are hidden they are more surprising.

TERMS OF DELIVERY AND CHARACTERISTICS OF THE PHOTOGRAPHIES

- All participants can to send their pictures from **September 30th until November 24th 2019** included (until and no later than 23:59 GMT+1)
- Black-and-white photos and colour photos, with horizontal or vertical orientation in **JPG, PNG and TIFF** formats are accepted. *(For the calendar, only horizontal orientation will be accepted).*

TECHNICAL CHARACTERISTICS FOR THE CALENDAR 2020

12 pictures will be selected for the Calendar 2020 of Postcards from Civitavecchia.

Participants need to bear in mind that, exclusively due to technical reasons, the pictures for the calendar must follow these characteristics:

- Minimum resolution of **300 dpi**
- Horizontal orientation (3:2) with dimensions of at least 30 x 20 cm

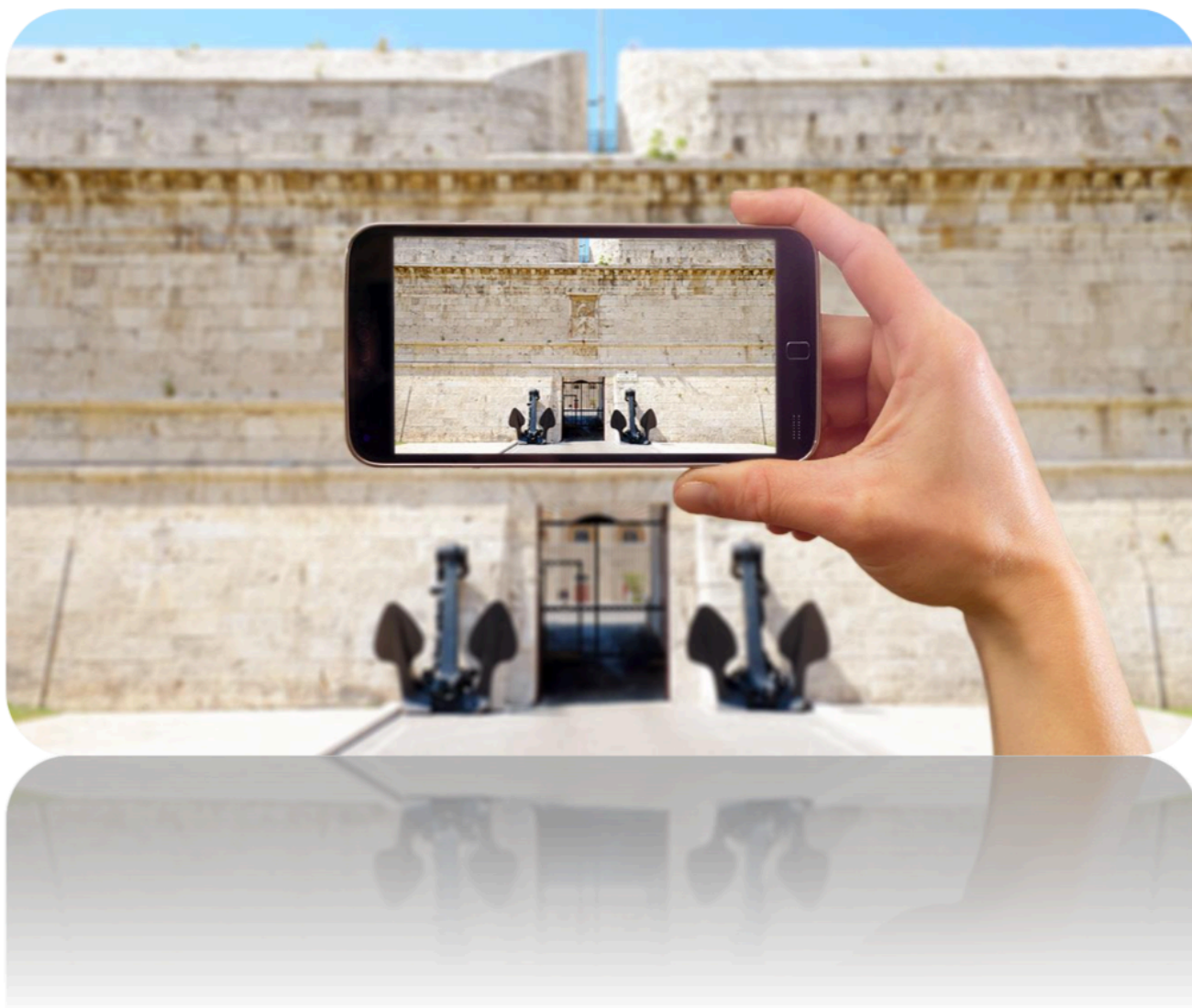
Pictures that do not meet these requirements will be automatically excluded from the Calendar. Excluded pictures will, nonetheless, be posted on Port Mobility webpages and social pages.

- direct organisers abstain from participating in the contest;
- all pictures collected participating in the contest will be examined and judged by a qualified expert jury.



The news for the 5th edition are not over! This year we have decided to give away prizes for the 12 winning pictures that will appear on the new Calendar 2020.

The 12 photographers selected for the Calendar will receive a €50 Amazon voucher and 3 wall and table calendars.



PRIVACY POLICY

1.Treatment of personal data

Under the art. 13 of EU General Data Protection Regulation 679/2016/CE, S.p.A., we would like to inform you that the personal data you provide for the contest “Postcards from Civitavecchia 2020” (from now on, the “Contest”), including the data provided through the website www.portmobility.it, will be processed by Port Mobility SPA (from now on, the “Company”) as data holder, in manual, printed, electronic or telematic mode.

In its own quality of data holder, the company proceeds to save personal data conferred in a server located in Europe. The database is accessible only by authorized persons, ensuring the security and confidentiality, thanks to the adoption of safety measures designed to prevent the loss of data, illicit or incorrect use and unauthorized access. The period of storage of the data is determined on the basis of the objectives underlying the treatment operations implemented and had regard to the type of the data given. In any case the duration of the retention of data will exceed the time strictly necessary to fulfill the purposes for which it was provided by the present disclosure.

2.Finality of the treatment

The personal data are collected and processed by the company exclusively for managing its registration at the site and the participation to the contest as well as for administrative purposes.

The data you conferred may also legitimately be used by Port Mobility to comply with legal obligations to which the company is subject, or even in the cases in which the treatment is necessary for the protection of the rights of the company and/or its dependants. The aforesaid purpose of treatment does not require your consent.

Thus the activities of treatment which are entrained will be implemented following the simple conferral of data from your part.

3. Conferment of data

The conferment of data for its part is optional: however, the absence makes it impossible to participate in the contest and to respond to any winnings.

4. Notification and dissemination of data

The personal data may be communicated to third parties responsible for the execution of the processing operations within the framework of the objectives referred to in point 2, and to this end appointed external responsible of the treatment. Among them we indicate Euromedia S.r.l., for the fulfilment of contractual obligations of Port Mobility Spa in your regard within the scope of the registration to the site and of the management of the contest. The communication of the data will be limited to European territory in respect of current legislation. Your data will not be subject to dissemination.

5.Data holder

The data holder is Port Mobility Spa.

6.Responsible for data protection

7. Rights of the user

As concerns the treatment of your personal data, you may exercise the rights referred to in Articles 15 and following of the EU Regulation 679/2016 by request addressed without formality to the data holder of the treatment, writing us an email to Dpo@innovationlab.srl. This request will be provided a suitable answer without delay.

In particular, you have the right:

- to access to personal data that concern you and to obtain all the information concerning the treatment of the same data listed by the Regulation;
- to obtain the amendment, and integration, respectively, of incorrect or incomplete data;
- to obtain the cancellation of his data in the situations provided for by Article 17 of the Regulation;
- to obtain the limitation of treatment in cases provided for by Article 18 of the Regulation;
- to receive from the holder of the personal data in structured format, of common use and readable by automatic device and to transmit them to another holder of the treatment (Portability);
- to submit a complaint to the supervisory authority about the treatment of data that concern him, within the meaning of Article 77 of the Regulation.

8. Underage users

Site registration and participation in the competition are allowed only to users older than sixteen years old. In case of users younger than 16, you need the written consent of both parents or guardian.
